The regular meeting of the Clearfield County Commissioners was held on Tuesday, August 14, 2018 with Chair Sobel conducting the meeting. Minutes of the previous meeting of July 24, 2018 were approved by motion of Commissioner McCracken, seconded by Commissioner Scotto; motion carried unanimously.

Controller Adamson presented the following bills for approval: General Fund, \$1,197,848.22; Liquid Fuels Fund, \$4,382.56; 911 Fund, \$414.88; Children Youth Services Fund, \$261,270.57; Domestic Relations Fund, \$748.69. Approval of the bills by motion of Commissioner Scotto, seconded by Commissioner McCracken; motion carried unanimously.

NEW BUSINESS

Chair Sobel presented a Premium Only Plan Description and Adoption Agreement. Solicitor Kesner explained that the document pertains to the Section 125 Premium only plan with respect to County health insurance. Motion to execute the documents by Commissioner McCracken, seconded by Commissioner Scotto; motion carried unanimously.

Jodi Brennan presented a Rescission Agreement between the County and Colver Development Corporation. Ms. Jodi explained that over the past five years the County has set aside Affordable Housing Trust dollars for the development of Leonard Street Gardens a 30 unit elderly housing building at the Professional Office Park. Colver was not able to secure additional funding for the project therefore the County will reallocate the funds to other projects. Both the County and Colver have mutually agreed on the Rescission Agreement and any obligation to each other arising from the original agreement. Motion to execute the rescission agreement by Commissioner Scotto, seconded by Commissioner McCracken; motion carried unanimously. Solicitor Kesner is also reviewing a request by Colver to refund any monies that they had paid as a deposit for Lot#6 at the Professional Office Park. Solicitor Kesner found in the Option Agreement signed in 2016 a deposit of \$4,700 was due. Solicitor Kesner asked Controller Adamson to research whether any funds were received and to advise.

Solicitor Kesner began discussion on a Tax Lien on a property located in Houtzdale Borough on Brisbin Street. Houtzdale Borough acquired the property in 2016 and it was subject to Tax Claims on behalf of the three taxing districts. Houtzdale Borough came to the Comissioners asking that the taxes be released and forgiven. Solicitor Kesner advised that the County have no authority to release a Tax Lien. Solicitor Kesner said there is an option where a donation of property can be made that will allow a discharge of Tax Claims. The donation of property can be made to a municipality, municipal authority. When the donation is made a notice is given to the 3 taxing districts and have 3 options they are as follows: (1) Affirmatively release its tax claim on the subject property by official action at a public meeting (2) Participate in negotiations with the Borough for settlement and released of tax claim (3) Do nothing and after thirty (30) days the County's tax claim will be deemed released. Dan Nelson, Solicitor for Houtzdale Borough said the building in question is a dangerous and dilapidated structure and the Borough sent notices to the taxing districts requesting release of the tax claim. Houtzdale Borough is ready to have the building demolished and have received bids for the project. The Commissioners discussed the matter and spoke that traditionally the County has not forgiven tax claims. Commissioner Sobel suggested some type of negotiation process for the tax claim. Solicitor Kesner reviewed the options again at the request of Commissioner McCracken. Commissioner Scotto asked what the cost is to demolish the structure; Mr. Nelson replied approximately \$9,000. Commissioner McCracken commented that the Borough will never recoup the funds that they are expending to demolish the building and the costs associated with it. Mr. Nelson plead with the Commissioners to consider his request as this building a public safety concern and it is feared the building is going to fall down and harm someone. Commissioner McCracken then made the motion to exercise option #1 Affirmatively release its tax claim on the subject property by official action at a public meeting; Commissioner Scotto seconded the motion with the understanding that the municipality followed the proper procedure. Solicitor Kesner explained that this is all conditioned upon Houtzdale Municipal Authority accepting the deed from Houtzdale Borough and if that does not occur the claim remains. Commissioner McCracken said that this was a special situation and after research from the Solicitor, the County had the option to exercise #1. Motion was made by Commissioner McCracken, seconded by Commissioner Scotto; motion carried unanimously.

Chair Sobel presented Purchase of Service Agreements for the following: Community County Services; Dr. Allen Ryen; Children's Aid Society. Motion to approve the agreements by Commissioner McCracken, seconded by Commissioner Scotto; motion carried unanimously.
